Annual FoxMasters Tournament Rules

1. All contestants must have a valid Minnesota fishing license.
2. All contestants must abide by all Minnesota fishing regulations.
3. All teams must fish from a boat. (No fishing from shore allowed)
4. All boats must comply with all Minnesota and local laws and regulations.
5. All boats must be made available to inspection by tournament officials at Everett Park prior to starting.
6. All boats will start from tournament headquarters. (but may launch at ramp of angler's choice)
7. Boats will take off single file in the order that Paid entries are received.
8. Life jackets must be worn at start of tournament.
9. Once the tournament has started no boat shall go ashore except at Everett Park. (Exception: severe weather)
10. No boat shall come in contact with another boat on the water. (Exception: emergencies)
11. Contestants must make a decision once a fish is caught whether to reduce it to possession or return it to the water. A fish once reduced to possession may not be released later.
12. No frozen or discolored fish will be allowed.
13. All teams must register their catch.
14. All boat boards must be returned to the weigh master.
15. No boat shall obstruct channels in any way by drift fishing or by anchoring.
16. In case of a tie, the person with the most rough fish will be awarded the prize.
17. Any team or team member caught breaking any of the rules will immediately disqualify that team.
18. All decisions of the judge or judges are final.
19. Competitors in F.L.C.L., Inc. tournaments are expected to follow high standards of sportsmanship, courtesy, safety and conservation.
20. Fox Lake Conservation League, Inc. reserves the right to reduce cash prizes paid according to the number of registrations received if not sold out, and the right to cancel said tournament if enough registrations are not received to make it a contest. In the event of Cancellation, all monies paid will be returned to the team captain at the address on the registration form the week following said tournament.
21. Registrations will be limited to the first 50 received, and, if 50 registrations are received prior to 8:00 a.m. the day of the tournament, the tournament will be considered full as of the date the 50 registrations are received and no further registrations will be accepted.
